

**RESOLUTION #2001-03  
ESTABLISHING PENALTIES, FINES & FEES  
FOR VIOLATION OF CITY ORDINANCES**

**WHEREAS**, the City Council of the City of Philip, South Dakota, establishes the following fines and penalties for violation of the ordinances of the City of Philip, South Dakota’s Revised Ordinances established during the 2001 Ordinance Revision as listed below; and,

**WHEREAS**, this resolution will replace Chapter 17 of the 1989 Revised Ordinances of the City of Philip, South Dakota and be established as the City’s Fine Schedule in accordance with Chapter 13 of Ordinance #2001-01 Ordinances in Revision of the City of Philip, South Dakota;

**NOW THEREFORE BE IT RESOLVED**, that the following fines and penalties be and hereby are established:

Any person who violates the Ordinances of the City of Philip, South Dakota, as listed below shall in addition to such court costs as may be imposed, be fined/penalized in the following manner and/or sums.
